# **Description of Change:**

The 3300V fast recovery diode module products listed above will be discontinued. Powerex recommends that customers that have used those modules to consider using the 3300V modules in the newer packages for possible replacements.

## **Reason for Change:**

The modules listed above were constructed in a package that was not compatible with the automated manufacturing process methods that Powerex has developed. The new package design will be compatible with that automated manufacturing process which is expected to increase our efficiency and reduce the variability that exists in manual assembly processes.

#### Identification of Change:

The recommended replacement products are identified with different part numbers than the original modules. The recommended replacement modules will also be in a distinctively different package.



#### **Original Module Package**

Module case did not surround the mounting screw hole on both sides. A small portion on top of the baseplate was not covered by the module case.



#### New Module Package

Module case surrounds the mounting screw hole on both sides

A last-time buy for the 3300V modules in the previous package design will not be offered for quantities less than Time Schedule for Change: a minimum of 500 pieces.
