

Description

The SKYFR-000736 is a single-junction circulator designed for wireless infrastructure applications. It operates over the frequency range of 791 to 821 MHz. Insertion loss is less than 0.30 dB over an operating temperature range of -40 °C to +105 °C.

The SKYFR-000736 comes in an industry-standard surface mount package and is designed for automated SMT placement.




Figure 1. SKYFR-000736 Block Diagram

A block diagram of the SKYFR-000736 is shown in Figure 1. The absolute maximum ratings of the SKYFR-000736 are provided in Table 1.

Electrical specifications are provided in Table 2. Plating information is shown in Table 3.

Figure 2 shows the package dimensions and recommended PCB footprint. Tape and reel dimensions are provided in Figure 3.




