


Figure 1. Device Package




Figure 2. Internal Connections




Figure 3. Typical Pulsed Current Gain vs.
Collector Current




Figure 5. Base-Emitter Saturation Voltage vs.
Collector Current




Figure 7. Collector Cut-Off Current vs.
Ambient Temperature




Figure 4. Collector-Emitter Saturation Voltage vs.
Collector Current




Figure 6. Base-Emitter On Voltage vs. Collector Current




Figure 8. Collector-Emitter Breakdown Voltage with Resistance Between Emitter-Base





Figure 9. Collector Saturation Region






Figure 11. Gain Bandwidth Product vs. **Collector Current**




Figure 12. Switching Times vs. Collector Current




Figure 13. Power Dissipation vs. **Ambient Temperature**




Figure 14. 6 LEAD, SUPERSOT6, JEDEC MO-193, 1.6 MM WIDE
